We would like to take this opportunity to inform you of the method implementation of the fee at The Address Hotels + Resorts.

Effective 31st March 2014, guests staying at any of The Address Hotels & Resorts will be subject to the Tourism Dirham Fee of AED 20 per bedroom, per night. This is payable by the guest upon check-out. The fee will be posted on a separate line, on the guest's bill.

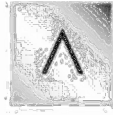

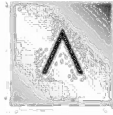
